TNCAC'S STAFF MEMBERS REGULARLY FIELD CALLS FROM CAC DIRECTORS DURING TIMES OF CRISIS, PROTOCOL QUESTIONS, EMPLOYEE CONCERNS AND TO ADDRESS CHILD PROTECTIVE INVESTIGATION TEAM INTERACTION AND COMMUNICATION.
