Since its establishment in 1994, Summer on the Hill (SOH) has provided important educational opportunities to 1,060 promising, low-income public school students from the Bronx, Washington Heights, and Harlem The average annual income of SOH families is \$45,000 Only 40% of SOH parents hold a college degree Despite many challenges to achievement, SOH students are motivated to work hard and accomplish their goals The following list indicates the range of achievement at SOH - Attendance and Attrition Students in the Grade 3-8 Program demonstrated their enthusiasm for SOH by attending the academic year Saturday program - a sixth day of school - at the impressive attendance rate of 88%-90% SOH's attrition rate is approximately 5% yearly - Middle School Placement SOH has placed over 120 elementary level students in independent schools Without SOH's guidance, it is unlikely that families would have known about and applied to the schools listed here (all SOH students attending independent schools receive enough financial aid to make their enrollment possible) Since 2004, SOH has placed 49 boys at the George Jackson Academy, 50 students at the De La Salle Academy, and 20 students at Horace Mann's Middle School Students have also been placed at Calhoun, Fieldston, Nightingale Bamford, Riverdale Country, and St Bernard's - High School Placement Between 2010 and 2012, 28 SOH students were accepted to specialized NYC public high schools Bronx Science (11), Brooklyn Latin (1), Brooklyn Tech (1), HS for American Studies at Lehman (5), HS for Math, Science, and Engineering at City College (6), LaGuardia HS (3), and Stuyvesant (1) During this period, students were also accepted to boarding schools (St Paul's, Phillips Exeter), Catholic schools (Mt St Ursula, Fordham Prep), and independent schools (Horace Mann, Riverdale) - College Placement 92% (215) of SOH's 2004-2012 high school graduates have matriculated in over 125 colleges and universities, including Barnard, Boston College, Bowdoin, Columbia, Cornell, CUNY Macaulay Honors, Dartmouth, Harvard, Middlebury, MIT, SUNY Binghamton, University of Pennsylvania, and Yale In 2011, a high school senior was accepted to all 12 colleges and universities to which she applied She is now a sophomore at Harvard - SOH college graduates are working in education, finance, health, insurance, and technology, or are enrolled in graduate or medical schools Two SOH college graduates are also volunteer mentors to SOH high school students in our Mentor Fellowship Program - Awards In March 2009, Dr McIvor, SOH's founder and Executive Director, received the Lewis Hine Distinguished Service Award for his work in expanding educational opportunities for low-income youth - Recognition from Foundations Since 1994, SOH has received over \$7 million in grants and individual gifts In 2012, SOH received a major three-year grant from The Heisman Trophy Trust Recent grants have come from these foundations Altman, American Eagle, Austin, Capital One, Charina, Colgate-Palmolive, Davis, Donchian, Fordham St Foundation, Samuel Freeman Charitable Trust, William T Grant, Charles Hayden, Niles, Oaklawn, Pforzheimer, Time Warner, Vogler, and the Yankee Stadium Community Benefits Fund Two New York City Councilmen awarded discretionary grants to SOH The NYC Department of Education and the NYS Department of Health have supported SOH's meal programs SOH is deeply grateful to the Horace Mann School for its gift-in-kind of facilities and supportive services
