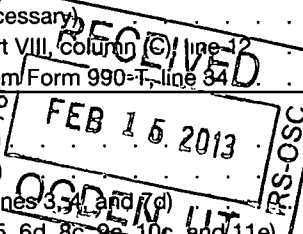

Puerto Rico Public Housing Administration (Project Learn Program):
 Project Learn is a comprehensive program that impacted 2,367 participants between the ages 6 through 18, and 2,747 adults through its Family Support Program, for a total of 5,114 participants. Participants took part in a fun and secure environment to develop their full potential as productive individuals. Programs supported included Power Hour, Torch Club, Keystone Club, Goals for Graduation, Visual Arts, Dance and Theater, and Sports and Recreation. All participants were exposed to educational forums, prevention programs against use and abuse of alcohol, tobacco and other drugs, family support systems, community development programs, and sports and recreation programs. For fiscal year 2011-2012, 100% of the work plan presented to PRPHA was accomplished. Major program results are as follows: 84% of participants are at grade level for age; 92% of participants are expected to graduate from high school and 84% of participants expect to attend college; more than 80% of participants abstained to use alcoholic beverages, tobacco or other drugs; and most participants has increased their knowledge in relation to sexuality and consequences of sexual relations at an early age.

21st Century Community Learning Centers: (Power Hour; Tutoring assistance; Reading-writing; Spanish, Math, English courses)
 21CCLC is a program which main objective is to improve academic progress, as well as technology skills of participants. During fiscal year 2011-2012, 1,503 participants benefited from the program. At least 1,256 participants attended tutoring service for 30 days or more. Program results statistics are as follows:
 * 43% of participants increased at least .25 grade average in Spanish courses
 * 93% of participants advance grade or graduate
 * 5% of participants improve their skills in math and 12% in english
 * 50% of participants improve their overall conduct and discipline in the classroom
 * All participants participate in sport and recreational activities and approximately 80% were benefited from art programs
 * Parents of participants took part of educational forums and employment opportunities forums, family time management and healthy lifestyles.
