THROUGH A STATEWIDE, PUBLIC-PRIVATE COALITION, THE CAMPAIGN IS WORKING TO ENSURE THAT ALL CHILDREN HAVE NUTRITIOUS FOOD AT HOME, AT SCHOOL, AND IN THEIR COMMUNITIES. THE GOAL IS TO END CHILDHOOD HUNGER BY 2015.

THE SUPPLEMENTAL NUTRITION ASSISTANCE PROGRAM (SNAP), KNOWN AS THE FOOD ASSISTANCE PROGRAM IN COLORADO, IS A FEDERAL NUTRITION PROGRAM DESIGNED TO PROVIDE LOW INCOME HOUSEHOLDS WITH THE FINANCIAL RESOURCES TO PURCHASE GROCERIES. AS PART OF HUNGER FREE COLORADO'S WORK, WE PROVIDE TRAINING, TOOLS AND SUPPORT TO COMMUNITY PARTNERS THROUGHOUT THE STATE TO MAKE SNAP MORE ACCESSIBLE TO INDIVIDUALS AND FAMILIES. THE PROGRAM INCLUDES APPLICATION ASSISTANCE TO CLIENTS, SNAP OUTREACH TRAINING FOR COMMUNITY PARTNERS, AND ASSISTANCE FOR COUNTY DEPARTMENT OF HUMAN SERVICES OFFICES.

HUNGER FREE COLORADO LAUNCHED THE HUNGER FREE HOTLINE (THE "HOTLINE"), ASSISTANCE IN MAY 2011. THE TOLL-FREE, BILINGUAL HOTLINE IS A FREE "ONE-STOP" RESOURCE THAT OFFERS GEOGRAPHICALLY BASED REFERRALS TO BOTH PUBLIC AND PRIVATE FOOD ASSISTANCE PROGRAMS THROUGHOUT THE STATE OF COLORADO. DURING THE SIX MONTH PERIOD 1/1/2012 THROUGH 6/30/2012 7,658 HOUSEHOLDS RECEIVED INFORMATION ABOUT HOW TO ACCESS FOOD RESOURCES IN THEIR COMMUNITIES. THESE RESOURCES INCLUDED FOOD PANTRIES, MEAL PROGRAMS AND PUBLIC HEALTH AND NUTRITION PROGRAMS.
