PART III – STATEMENT OF PROGRAM SERVICE ACCOMPLISHMENTS

The Briar Woods High School Music Boosters Association (BWHSBMA) was organized to provide support to the various band music programs – Marching Band and Color Guard, Jazz Band I and II, Symphonic Wind Band, Symphonic Band, Winter Guard and Winter Drum Line – at Briar Woods High School. This support is provided through the purchase of uniforms, costumes, t-shirts/sweatshirts, jazz shirts, competition fees, additional band equipment, instruction and supplies. This is the 7th year of the high school which is a part of the Loudoun County Virginia Public School District.

Funds raised by the BWHSMBMA were used to purchase uniforms for new members of the Marching Band, props for the Marching Band and Color Guard, Winter Color Guard and Winter Drum Line, new concert attire for band members as well as instruction, music arrangements, entrance fees and travel costs to inter-school competitions. Special event t-shirts and sweatshirts were also acquired for the students. Funds were also used to purchase additional band equipment. As the music program continues to grow in numbers, so do the accomplishments the students have obtained – this past year there were 3 All State Musicians selected from the Briar Woods Band Program.

The BWHSMBMA supports the Marching Band and Color Guard, which in addition to performing at ten football games, performed in four area competitions. The BWHSMBMA paid entrance fees for all the competitions as well as entrance fees for the Winter Guard which performed in four area competitions. An overnight trip with competition performances by BWHS bands and BWHS orchestra was coordinated and supplemented by the BWHSMBMA this past year; in which all bands won top honors. In addition, the BWHSMBMA supports numerous students who compete for positions in All District, All Region and All State Orchestras and Bands. Finally, the BWHSMBMA awarded \$3,000.00 in scholarships.
