Over 160 volunteers assess agencies throughout the year to ensure that community dollars are well invested to make the greatest impact.

United Way 2-1-1, operated by the Baton Rouge Crisis Intervention Center, is an information and referral telephone service that helps individuals locate needed services such as an open shelter or warm meal. Counselors are on duty each day and can be reached for information referral assistance by dialing 2-1-1 in the 10-parish area.
