Emergency Assistance provided financial assistance (mostly rent and utility) to households facing eviction, utility turn-off, etc. Funding came from churches, private donations, and a government grant. The program prevented 205 evictions and 319 utility turn offs. It paid for 21 prescriptions, 19 security deposits, 14 GED test fees or college application fees. And it assisted in 2 funerals. The program, in conjunction with Second Harvest, also distributed food boxes to needy residents of the neighborhood.

The adult learning center enrolled 231 adult students during the year. 19 students earned their GED diplomas. Seventy-three students successfully completed at least one NRS educational level. Students amassed 11,686 hours of class time. Several graduates moved on to college and technical school programs after graduation.

The after-school recreation program provided neighborhood children with a safe, supervised place to play after school. On average 35 young people participated in the program each day. A summer program, run by residents of the neighborhood, enrolled about 40 neighborhood children.

Form 990, Part III, Line 2: Hope House started a small Career Development Program in December 2011. This program assists participants in our adult learning center and residents of our service area in preparing themselves for employment and/or enrollment in college or other training programs. It includes career awareness, job soft skills, job search skills, applying for college, etc. It is included as part of our adult education program.

Form 990, Part III, Line 4d: Other program services: Low cost rental - expenses were \$7,809 and revenues were \$16,415; free coffee house for homeless people - expenses were 4,940 and there were no revenues; workshops on poverty and justice - expenses were \$579 and revenues were \$1,330.

Form 990, Part V, line 3a: We had no unrelated business gross income.

Form 990, Part VI, line 2: Two of our directors are related as mother and daughter.

Form 990, Part VI, line 19: Our Form 990's are posted on Guidestar. They are also available on request at Hope House, as are our governing documents, and conflict of interest policy. No one has asked us to see any of these during the fiscal year.

Form 990, Part VI, line 11b: Board members did not review the 990 before it was sent in. Board members will do so at their next meeting. We will read through it, ask any questions, and discuss any issues raised.

Form 990, Part VIII, line 11a: We sold a property (a three-plex) that we had used earlier in our transitional housing program, which no longer exists. We were and are concerned about future funding and our ability to maintain our programs, so we sold the property to insure that our other programs could continue during very uncertain times.

Form 990, Part XI, line 5: Changes in net assets or fund balances: During a review of the 2011 sale of property, it was noted that certain properties, including the property being sold, were depreciated beyond their recorded book value. Additionally, it was determined that certain liabilities and intracompany payables were not accurately recorded.
