**Clinic Services:** MHSSO provides treatment for the most challenging and complex mental illness and substance abuse issues. Our clinic staff assesses, diagnose, and develop individualized treatment plans for each person served. Psychiatric services are complemented with care/case management. Group and individual counseling services and other interventions as identified in the treatment plan, all conducted by fully licensed personnel. Rehabilitation services are provided in both individual and group settings to assist with the development of daily living/recovery skills. Consumers participating in the Psycho-social Rehabilitation (PSR) program are provided with transportation and participate in a "work ordered day" that further efforts at recovery.

**Residential Treatment Center:** Our adult living facility is licensed by the state of Oklahoma Department of Health and Certified by the Oklahoma Department of Mental and Substance Abuse Services as an "enhanced" care setting. In addition to housing, mental health services coordinated with the local mental health clinic, may include group and individual therapy sessions and psychiatric care consistent with the individualized treatment plan. Consumers are assisted with personal hygiene, housekeeping, as well as monitored medication management. Treatment plans typically include Psycho-Social Rehabilitation services provided by MHSSO

**Crisis Diversion:** 24-hour emergency on call system for psychiatric emergencies. A Qualified Mental Health Professional (QMHP) is available to assess persons in crisis and determine if they need psychiatric hospitalization or if services can be safely provided in the community. The goal of Crisis Diversion Services is hospital diversion, by appropriately assessing the consumer's needs, and providing him/her immediate access to community resources and treatment services as appropriate.
