Community volunteers serve as the review panel for this process.**

**Success by 6/Smart Start(grant) provides support to parents/caregivers to enable children birth-6 years old to enter school ready to succeed. Programs include but are not limited to Bibs and Books, mothers of newborns receive parenting information, a book and bib (2000 births annually in 3 hospitals); Leap into Literacy story time training teaching appropriate reading techniques in 40 childcare centers/homes (reaching 701 unduplicated and 640 duplicated children annually); and Raising a Reader, 1,500 pre-K and Head Start children participate in weekly exchanges of books in a take home book bag with caregivers reading over 1000 titles.**
