a demonstration of our shared beliefs. Interfaith Ministries for Greater Houston provides meals to homebound seniors, refugee
resettlement assistance, interfaith relations services, and disaster preparedness services.

Senior Services includes the Meals on Wheels program and the Animeals on Wheels program. Meals on Wheels delivers hot,
nutritious weekday meals to homebound senior citizens, as well as breakfast and weekend meals to the most frail and isolated
seniors. IM delivered almost 1.4 million meals, with an average of 4,400 seniors served each weekday in this fiscal period. The
Animeals on Wheels program delivers pet food to seniors with pets, so they will not have to share their limited food resources with
their animal companions. Almost 450 seniors and over 1,000 pets participate in this program, with over 80,000 pounds of donated
pet food delivered by volunteers in this fiscal period.
The Meals on Wheels program received \$72,000 worth of donated facility space in this fiscal period.

4b (Code) (Expenses \$ 2,796,468 including grants of \$ 1,497,058) (Revenue \$ 0)
The Refugee Services program assists in the resettlement of refugees fleeing their homeland in fear of political, social or religious
persecution. Services provided include food, housing, transportation and medical assistance, donated furniture, home furnishings
and clothing, cultural orientation and employment assistance; translation and educational assistance, and other services designed
to help refugees become self-sufficient within six months of arrival in Houston. In this fiscal period, IM resettled over 500 refugees
from 15 countries, 92% of whom were self-sufficient within six months.
The Refugee Services program received over \$99,000 worth of donated refugee housing and other professional services in this fiscal
period

4c (Code) (Expenses \$ 285,360 including grants of \$ 0) (Revenue \$ 30,900)
The Interfaith Relations program fosters understanding, respect and engagement among people of all faiths through educational
opportunities and community service. Features of the program include Dinner Dialogues (over 450 participants), Women's Retreat
and other women's programming (200 participants), the iFaith Youth Program (over 150 participants), and over 40 other educational
events.
The Disaster Preparedness and Response program works with nonprofits, religious institutions and government agencies year-
round to prepare for disasters. IM's Director of Disaster Preparedness served as Chair of the Voluntary Organizations Active in
Disaster (VOAD) consortium, which helps plan and prepare for a coordinated effort of Houston resources in times of disaster.
