THE MAJORITY OF NOEP'S FUNDING COMES FROM THE CANCER PREVENTION AND RESEARCH INSTITUTE OF TEXAS (CPRIT), A STATE AGENCY FORMERLY KNOWN AS THE TEXAS CANCER COUNCIL. ADDITIONAL FUNDING IS RECEIVED FROM LIVESTRONG, A CANCER EDUCATION AND ADVOCACY FOUNDATION, TO COMPLETE SMALL PROJECTS THAT FIT WITHIN THEIR AGENDA. NOEP ALSO HAD A CONTRACT WITH THE DEPARTMENT OF STATE HEALTH SERVICES (DSHS) COMPREHENSIVE CANCER CONTROL PROGRAM.

DURING THE PERIOD JULY 1, 2011 THROUGH JUNE 30, 2012, NOEP EDUCATED 4b (Code) (Expenses \$ 906,528. including grants of \$) (Revenue \$ 845,314.) THE TEXAS PEER ASSISTANCE PROGRAM FOR NURSES (TPAPN), A PROJECT OF THE TEXAS NURSES FOUNDATION, BEGAN OPERATIONS ON MARCH 1, 1987, AS AN "APPROVED" PEER ASSISTANCE PROGRAM UNDER THE TEXAS HEALTH AND SAFETY CODE, CHAPTER 467, PEER ASSISTANCE PROGRAMS.
