Case management programs work with individuals and families who are homeless or at-risk of becoming homeless to gain housing stability. They may receive financial assistance toward rent, utilities or other housing expenses, education on budgeting and financial management, and work with a case manager to set goals to increase income and decrease expenses so that they will be self-sufficient.

Catholic Charities disaster response team worked in cooperation with FEMA and other community resources to provide assistance to 2,250 people impacted by the 2011 Central Texas Wildfires.

4b (Code:) (Expenses \$ 346,738 including grants of \$ 13) (Revenue \$ 326,938)

Immigration Legal Services is accredited by the Board of Immigration Appeals (BIA) and has been providing quality legal, low-cost immigration and legal services to Central Texas immigrants from more than 55 different countries since 2002. The program is recognized by the Board of Immigration Appeals (BIA) and assists U.S. citizens, Lawful Permanent Residents (LPRs), and immigrants with family reunification applications for lawful permanent residency, adjustment of status, and naturalization, and special assistance to immigrant survivors of domestic violence and other violent crimes. The program also conducts community outreach to enhance awareness of the benefits of citizenship and legal immigration remedies.

4c (Code:) (Expenses \$ 288,921 including grants of \$ 27,524) (Revenue \$ 241,590)

The Gabriel Project Life Centers work with mothers and fathers who are preparing for the birth of a child or who have a child under the age of 1 year. Services include material assistance in the form of clothing, diapers, baby furniture, etc., education on pregnancy and parenting topics including safety, nutrition, and human development, and mentoring on parenting and pregnancy related issues, with referrals to appropriate organizations for physical and mental healthcare, housing, financial assistance, food or other needs.
