

The Temporarily Restricted gift of \$25,000 was included in the amounts reported in Part 1, Line 1, Line 9, Line 17, and Line 20. Also in Part II Line 22, Line 25, and Line 28a.

Part II, Line 24 includes flowers for sick members, bank charges, the fee for the financial audit and Compilation Report, and Prepaid Insurance to be used to cover two concerts performed in Oct and Dec, 2012.

Part IV c: All compensation listed is amounts paid to independent contractors, under contract, and reported to the IRS on Forms 1099-MISC.

Part V, Line 35: All income reported in Part I, Line 6d was from unrelated business activity NOT regularly carried on and only for the convenience of the orchestra members; e.g., an annual silent auction of items donated to the orchestra, concert recordings made for archival purposes and provided to orchestra members in exchange for donations to the orchestra, and rebate donations from grocery stores. All unrelated business activity was thus not reportable as taxable, as defined by the IRS, and no Form 990-T was prepared.
