THE PURPOSE OF YELLOWSTONE ACADEMY IS TO PROVIDE A HIGH QUALITY, FAITH BASED, PRIVATE SCHOOL EXCLUSIVELY SERVING CHILDREN LIVING IN POVERTY IN HOUSTON, TEXAS YELLOWSTONE ACADEMY OPENED ON AUGUST 21, 2002, WITH FOUR CLASSES OF THREE AND FOUR YEAR OLD STUDENTS DURING THE 2011-2012 SCHOOL YEAR, YELLOWSTONE ACADEMY SERVED 372 STUDENTS IN GRADES PK 3 THROUGH EIGHTH GRADE YELLOWSTONE IS ACCREDITED BY THE SOUTHERN ASSOCIATION OF COLLEGES AND SCHOOLS (SACS) THE MISSION OF YELLOWSTONE ACADEMY IS TO EXCLUSIVELY SERVE CHILDREN FROM LOW-INCOME FAMILIES WHO ARE LIVING IN ENVIRONMENTS GENERALLY CHARACTERIZED AS "AT RISK" THE COMBINATION OF ILLITERACY, DEPENDENCY, AND SINGLE PARENTHOOD DEFINE THE CYCLE OF POVERTY THAT THESE CHILDREN ARE GROWING UP IN AND ARE HIGHLY LIKELY TO REPEAT, ABSENT EFFECTIVE INTERVENTION YELLOWSTONE'S GOAL IS TO BRING ABOUT RADICAL CHANGE IN LIFE PROSPECTS IT INTENDS TO REACH CHILDREN IN CIRCUMSTANCES THAT PREDICT A HIGH PROBABILITY OF LIFE DYSFUNCTION AND TO PROVIDE THEM THE TOOLS AND ENVIRONMENT THAT LEAD TO A HIGH PROBABILITY OF LIFE SUCCESS THE FOLLOWING IS A SUMMARY OF THE STUDENT PROFILE 96% AFRICAN AMERICAN 2% HISPANIC 2% BI-RACIAL MEDIAN FAMILY INCOME IS \$10,410 93% ARE CHILDREN WHO LIVE IN SINGLE PARENT HOUSEHOLDS AS A RESULT OF THE FACTORS OF POVERTY, THE MAJORITY OF OUR CHILDREN COME TO SCHOOL LANGUAGE DELAYED, BEHIND GRADE LEVEL, AND AT RISK FOR FAILURE IN SCHOOL YELLOWSTONE ACADEMY'S EDUCATIONAL STRATEGY HAS BEEN SPECIFICALLY DESIGNED TO ADDRESS THESE CHALLENGES AND IS IMPLEMENTED WITH GREAT SUCCESS BY A CERTIFIED TEACHER AND WITH A LOW TEACHER/STUDENT RATIO IN EACH CLASSROOM IN ADDITION, EACH PK-5TH GRADE CLASSROOM HAS A FULL-TIME INSTRUCTIONAL AIDE YELLOWSTONE ALSO EMPLOYS A HEAD OF SCHOOL, EXECUTIVE DIRECTOR, DIRECTOR OF EDUCATION, SOCIAL WORKER, FACILITY OPERATIONS MANAGER, DIRECTOR OF VOLUNTEERS, DIRECTOR OF CO-CURRICULAR ACTIVITIES, OFFICE MANAGER, SECRETARY, TUITION COORDINATOR, DEVELOPMENT DIRECTOR, TWO DEVELOPMENT ASSISTANTS, ACCOUNTING CONTROLLER, HR ADMINISTRATOR, PART TIME ACCOUNTANT, TWO PE TEACHERS AND ONE PE AIDE, COMPUTER TEACHER, ART TEACHER, AND A PART TIME MUSIC TEACHER YELLOWSTONE ALSO EMPLOYS FOUR BUS DRIVERS AS WELL AS TWO ADULT BUS CHAPERONES FOR EACH OF ITS FOUR BUSES ALONG WITH A LARGE NUMBER OF VOLUNTEERS, THESE STAFF MEMBERS WORK TOGETHER TO CREATE AN ENVIRONMENT CHARACTERIZED BY STRUCTURE AND DISCIPLINE BUT ALSO ANIMATED WITH HOPE AND OPTIMISM THERE IS AN EXCITEMENT FOR LEARNING ALONG WITH AN INNOVATIVE STAFF DEVELOPMENT PROGRAM, THE SCHOOL USES THE BEST OF PUBLISHED AND TEACHER DEVELOPED CURRICULUM AND EMPHASIZES METHODS AND MATERIALS THAT ARE RELEVANT TO CHILDREN IN POVERTY AND FOCUS ON ACTIVE STUDENT INVOLVEMENT THERE IS CONTINUOUS EVALUATION OF STUDENT ACHIEVEMENT AND CURRICULUM IS ADJUSTED ACCORDINGLY THE PARENTS AT YELLOWSTONE ACADEMY ARE ENCOURAGED AND GIVEN EVERY OPPORTUNITY TO BE AN ACTIVE PARTICIPANT IN THEIR CHILD'S EDUCATION WITH THE EXCEPTION OF CHILDREN IN THE CUSTODY OF CHILD PROTECTIVE SERVICES, ALL FAMILIES PAY SOME LEVEL OF TUITION, WHICH IS SCALED BASED UPON THEIR INCOME PARENTS IN POVERTY ARE TYPICALLY NOT COMFORTABLE IN A SCHOOL SETTING SO A VARIETY OF STRATEGIES ARE USED TO CREATE A STRONG, POSITIVE PARTNERSHIP BETWEEN SCHOOL AND HOME THE SCHOOL HAD 92% OF THE STUDENTS RETURN FOR THE 2011-2012 SCHOOL YEAR AND HAD A 91% RETENTION RATE DURING THE SCHOOL YEAR, SOMETHING THAT IS HIGHLY UNUSUAL FOR THE POPULATION IT SERVES AS A RESULT OF THE SCHOOL'S SUPPORTIVE AND ACTIVE BOARD, YELLOWSTONE ACADEMY CELEBRATED SEVERAL SIGNIFICANT MILESTONES DURING THE 2011-2012 SCHOOL YEAR THIS WAS THE SCHOOL'S TENTH YEAR OF OPERATION AND ALSO THE YEAR THAT ITS GROWTH PLAN WAS COMPLETED WITH THE ADDITION OF EIGHTH GRADE THIS MEANT THAT YELLOWSTONE HAD ITS FIRST CLASS OF GRADUATING EIGHTH GRADERS, AND THOSE TWENTY-FOUR STUDENTS WERE PLACED IN PRIVATE, PUBLIC, CHARTER, AND MAGNET HIGH SCHOOLS THROUGHOUT THE CITY OF HOUSTON YELLOWSTONE'S MANY VOLUNTEERS, STAFF, AND BOARD MEMBERS CAME TOGETHER WITH THE FAMILY MEMBERS OF THE STUDENTS AT A JUNE 2012 CEREMONY TO CELEBRATE THIS MUCH ANTICIPATED GRADUATION THERE WERE SEVERAL OTHER SIGNIFICANT CHANGES AT YELLOWSTONE FOR THE 2011-2012 SCHOOL YEAR FIRST, A YEAR-ROUND SCHOOL CALENDAR WAS IMPLEMENTED STUDENTS ATTENDED SCHOOL THE SAME NUMBER OF DAYS PER YEAR, BUT THE CALENDAR WAS ORGANIZED TO GIVE ONE TO TWO WEEK BREAKS CONSISTENTLY THROUGHOUT THE YEAR INSTEAD OF THE TRADITIONAL MULTIPLE-MONTH SUMMER BREAK RESEARCH SHOWS THAT THIS AIDS IN PREVENTING THE LOSS OF ACADEMIC PROGRESS THAT LOW-INCOME STUDENTS SUFFER AFTER THE TRADITIONAL SUMMER BREAK WHILE YELLOWSTONE CONTINUES TO HAVE AN EXTENDED SCHOOL DAY, THE TIME WAS SHORTENED SLIGHTLY SO THAT THE BUSES WERE LEAVING SCHOOL BY 5 00PM RATHER THAN 5 30PM THIS CHANGE ALLOWED THE BUSES TO AVOID THE WORST OF DOWNTOWN RUSH-HOUR TRAFFIC AND TO COMPLETE THEIR ROUTES 45-60 MINUTES FASTER ALSO YELLOWSTONE INCREASED ITS MIDDLE SCHOOL SPORTS PROGRAM WITH THE ADDITIONS OF BOYS AND GIRLS CROSS COUNTRY AND TRACK TEAMS
