		Client Note 1 - Form 990-EZ, Part 1, Line 20The organization posted a prior period adjustment on their 2011 Form 990-EZ During the course of preparing the 2011 Form 990 it was discovered that the beginning balance of Cash was overstated in the prior year The adjustment to cash brings net assets to a more accurate amount based upon information that is available The Organization's bookkeeper is no longer with them As a result, there was not complete accrual bookkeeping performed for the year Using the bank statement information a set of cash basis books was prepared In preparing the cash basis books (for the purpose of preparing the 990 EZ) no accounts payable or accounts receivables were recognized Some of the adjustment is due to zeroing out the accruals (because no accrual information was available) The organization works on an on-going grant reimbursement method Revenue is not received unless the expenditure has been made Hence, it is reasonable to expect that payables are settled upon the receipt of grants receivable, and that receivables and payables approximate each other in amount
