SCHOLARSHIPS - ONE OF THE PRIMARY GOALS OF THE FOUNDATION IS TO SUPPORT PROGRAMS AND ACTIVITIES THAT WILL DIRECTLY IMPACT STUDENTS. BLUEGRASS COMMUNITY AND TECHNICAL COLLEGE IS EXPERIENCING THE HIGHEST ENROLLMENT NUMBERS IN ITS HISTORY. THAT TRANSLATES TO AN INCREASED NUMBER OF STUDENTS WHO NEED ASSISTANCE TO FURTHER THEIR EDUCATION. WHILE ENROLLMENT HAS INCREASED, STATE FUNDING FOR THE COLLEGE HAS NOT. THIS PUTS AN EXTRA FINANCIAL BURDEN ON THE COLLEGE AND, IN TURN, ON THE STUDENT. THE FOUNDATION NOW PROVIDES FINANCIAL SUPPORT FOR SEVEN SCHOLARSHIP PROGRAMS FOR THE COLLEGE. CURRENTLY, THE AWARDS RANGE FROM \$250 PER SEMESTER TO FULL TUITION, BOOKS, AND FEES, WITH APPROXIMATELY 43 STUDENTS RECEIVING FINANCIAL SUPPORT DURING THE FISCAL YEAR ENDING JUNE 30, 2011.
