Education - Through IDEA's student sponsorship program, 353 impoverished deaf children were funded to be able to attend Special Education Classes in the Philippines this past year IDEA also funded teacher training-in-service trainings as well as funded the purchase of school materials and equipment for classes In addition, the indigent deaf children were provided food and lodging while attending school Part of the funding was also allocated to provide vocational education and hands-on-training for deaf high school students in the Philippines
