STUDENTS, IN TURN, SET HIGHER GOALS FOR THEMSELVES. THE OBJECTIVE OF THE COLLEGE BOUND PROGRAM IS TO HELP THE ENTIRE FAMILY BETTER NAVIGATE THE ADMISSIONS SYSTEM AND TAKE ADVANTAGE OF THE RESOURCES OFFERED AT THEIR SCHOOLS.

FCE HAS DEVELOPED A COMPREHENSIVE COLLEGE RETENTION PROGRAM TO SUPPORT AND GUIDE FCE STUDENTS TO ENSURE THAT THEY OBTAIN A BACHELOR'S DEGREE. ONE HUNDRED PERCENT OF FCE'S STUDENTS GRADUATE FROM HIGH SCHOOL AND ENROLL IN POST-SECONDARY INSTITUTIONS. EIGHTY-FIVE PERCENT OF FCE COLLEGE STUDENTS COMPLETE COLLEGE WITHIN FIVE YEARS.

INSTITUTIONAL BUDGET CUTS HAVE LIMITED THE RESOURCES AVAILABLE FOR FINANCIAL AID. MANY SCHOOLS CAN'T MEET THE DEMONSTRATED FINANCIAL NEEDS OF LOW INCOME STUDENTS. FCE'S COLLEGE SCHOLARSHIP PROGRAM HELPS ADDRESS THE GREATER FINANCIAL NEEDS OF ITS STUDENTS PROVIDING SUSTAINABILITY GRANTS AND HENCE, PLAYS A KEY ROLE IN RETENTION.
