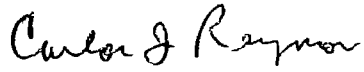

Note 1 - Description of Organization and Summary of Significant Accounting Policies

Organization - Marian Community Clinics, Inc. (the Clinic), located in Guadalupe, California, is a not-for-profit organization that operates clinics in the cities of Guadalupe and Santa Maria and was incorporated on January 15, 1997. The Clinic acquired the assets of two not-for-profit organizations and commenced operations on February 1, 1997. The Clinic in San Luis Obispo opened in fiscal year 2011-2012.

Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Significant Estimates - The Clinics considers its estimates for contractual allowances and bad debt allowance to be significant estimates as described below since industry and market conditions make it reasonably possible that estimates will change within one year of the date of financial statements and the effect of the change would be material.

Property and equipment - Property and equipment acquisitions are recorded at cost. Depreciation is provided over the estimated useful life of each class of depreciable asset and is computed using the straight-line method. Property and equipment acquired through donations are recorded at fair market value at the date received. The organization capitalizes all acquisitions of property and equipment with a value of greater than \$3,000.

Revenue Recognition - It is the policy of the Clinic to recognize revenue from grants and contracts to the extent of expenditures incurred not to exceed grant and contract awards. Patient revenue and third-party payer revenue is recorded at the Clinic's established rates with sliding fee scale adjustments, third-party contractual allowances, and adjustments which are deducted to arrive at net patient revenue.

Allowance for Doubtful Accounts - The Clinic uses the allowance method to record its bad debts. The Clinic's estimates of uncollectible accounts receivable range from 50% to 78% depending on Clinic location.

Classification of Net Assets - Net assets and revenue, expenses, gains and losses are classified based on the existence or absence of donor-imposed restrictions. Accordingly, net assets of the Clinic and changes therein are classified and reported as applicable as follows:

* **Unrestricted Net Assets** - Net assets that are not subject to donor-imposed stipulations or where donor-imposed stipulations are met in the year of the contributions.

* **Temporarily Restricted Net Assets** - Net assets subject to donor-imposed stipulations that may or may not be met, either by actions of the Clinic and/or the passage of time. When a restriction expires, temporarily restricted net assets are transferred to unrestricted net assets and reported in the statement of activities as net assets released from unrestricted net assets and reported in the statement of activities as net assets released from restrictions. The Clinic does not have any temporarily restricted net assets.

* **Permanently Restricted Net Assets** - Net Assets subject to donor-imposed stipulations that they be maintained permanently by the Clinic. Generally, the donors of these assets permit the Clinic to use all or part of the income earned on any related investments for general or specific purposes. The Clinic does not have any permanently restricted net assets.

Tax-Exempt Status - The Clinic is a not-for-profit corporation organized as described in Section 501 (C)(3) of the Internal Revenue Code and is exempt from federal and state income taxes under applicable provisions of the Internal Revenue Service and California Revenue Codes. The Clinics has no uncertain tax positions that would be material to the financial statements and its open tax years subject to examination are 2009, 2010 and 2011.

Related Organization

Marian Community Clinics, Inc. is supported by Marian Medical Center which is a member of Dignity Health, a system of 40 hospitals and medical centers in California, Arizona and Nevada. Dignity Health (formerly Catholic Health Care West) is a not-for-profit hospital provider. Marian Medical Center provides administration and management services to the Clinic.

Note 8 - Commitments and Contingencies

Operating leases - The Clinic leases facilities under operating leases which renew automatically each year. Total rental expense in 2012 for all operating leases was approximately \$368,000. In addition, the Clinic entered into long term leases for its Guadalupe Clinic and its San Luis Obispo Clinic. Future minimum rental payments required for succeeding fiscal years are as follows:

Program Funding - The Clinic has received revenue under state and county grants that are subject to review and audit by the grantor agencies. Such audits could lead to requests for reimbursement to the grantor agencies for expenditures disallowed under the terms of the grant. Continuing program funding is contingent upon availability of funds from funding sources and project performance. Funds are awarded on an annual basis upon receipt and approval of program applications.

Medicare/Medi-Cal Cost Report

The Clinic's Guadalupe office has elected to participate in the Rural Health Program. Under this program the Clinic is required to file a cost report at the end of its fiscal year. The purpose of this report is to determine whether interim payments received from Medicare and Medi-Cal exceed or are insufficient to cover expenses incurred for services provided to eligible patients of this program. This cost report is subject to review and audit by both the Medicare Fiscal Intermediary and Medi-Cal. As of June 30, 2012, management is of the opinion that settlement of this fiscal year's report would not be significant to the financial statements. No accrual has been made in the financial statements.

Note 9 - Going Concern

At the end of fiscal year 2012 \$6,411,845 was owed by the clinics to Marian Medical Center for expenses (payroll and accounts payable) which were paid through the hospital. As cash is received at the clinic it is used to reimburse the hospital. The hospital understands that the clinics run at a deficit and will not require payments over and above the cash on hand. From CHW/Dignity Health's perspective all Marian entities, including the clinics, are considered one service area and any cash shortfall is funded as an entire service area. The Marian Clinics were established to service the underserved and to help keep primary care providers in the area and it was never expected to produce an excess of income over expenses. The hospital has committed to insuring it is an ongoing concern and will continue to fund any shortfalls.

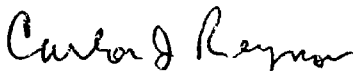
