AMERICAVIEW'S MEMBERSHIP OBJECTIVE IS THE DEVELOPMENT OF REMOTE SENSING CONSORTIA IN EVERY PARTICIPATING STATE, SUCH THAT THE ORGANIZATION BECOMES A NATIONALLY COORDINATED CONSORTIUM OF LOCALLY-CONTROLLED STATE-LEVEL CONSORTIA.
