The Hunt Institute 2012 Year-In-Review Summary

The Hunt Institute had a full year in 2012, hosting several significant convenings and activities. The year began with The Hunt Institute's 9th annual **North Carolina Legislators Retreat (NCLR)** on January 9-10, in Pinehurst, N.C. More than 60 legislators attended the event to learn more about the strategies to ensure that North Carolina's public schools prepare students with the skills and knowledge needed to be successful in college and career. Former North Carolina Governor Bev Perdue delivered a keynote address about the Career & College Promise program. As a follow up to the NCLR and direct requests of legislators, The Institute hosted a **dinner discussion** on April 24 to discuss in greater detail college and career readiness for students – including Advanced Placement and teacher support and accountability.

The Institute hosted its **2012 Governors Education Symposium, *Advance America | A Commitment to Education & the Economy***, on April 29-30 in Cary, N.C. The event was partnered with the Foundation for Excellence in Education, founded and chaired by former Florida Governor Jeb Bush. Eleven dignitaries and two first ladies attended, as well as U.S. Secretary of Education Arne Duncan. The focus was on strategies to ensure that all students graduate from high school ready to succeed in college or career.

The Hunt Institute cohosted the **North Carolina business leaders meeting** on May 30-31 in Raleigh, N.C., to examine the performance of public education and discuss the plan of action to transform the system to create a skilled workforce capable of competing and excelling in the 21st century global economy. Hunt Institute Foundation Board Members were featured, providing remarks to a gathering of top business executives, policymakers, and prominent education leaders. The Institute also provided a number of issue briefs addressing such topics as the critical role of rigorous standards and the current shift to the Common Core State Standards.

The Hunt Institute established itself as a dominant force in the world of social media in August with the launch of its blog, ***The Intersection***. This outlet serves as a platform for thoughtful conversation on the Common Core State Standards, education policy, leadership, and student success. Content is provided by members of the Hunt Institute team, guest contributors, and experts in the field.

The Institute brought together state teams to **set college- and career- readiness agendas** on October 1-2 in Atlanta. This was a first-time collaboration with the Southern Regional Education Board. The convening provided a valuable opportunity for more than 90 participants to gain insight into the specific policies, strategies, and partnerships needed to help further efforts to create a comprehensive college- and career-ready initiative.

A Hunt Institute's presence was also felt at **various events throughout the year**, including co-hosting, with the state of Georgia, the ***Common Core Georgia Performance Standards Telecast for Teachers***; CCSSO's annual national conference on student assessment and Summer Institute; Dr. Hung-His Wu's Mathematics Professional Development Institute at UC Berkeley, the National Conference of State Legislatures Summit, and Virginia Gov. Bob McDonnell's K-12 Education Reform Summit.

Solid, state-led Common Core implementation continues to unfold in states across the nation as the Hunt Institute **continued its efforts** to be a reliable, honest broker of information for partner groups, school districts, and grassroots organizations alike, and provide a platform to share resources or present new Common Core tools, materials, and leadership events.

The year concluded with The Institute honoring its 10th anniversary in existence with a **new logo**, and publishing another edition of ***re:VISION***, The Institute's policy primer. The December 2012 edition placed a spotlight on Career and Technical Education and the various efforts taking place on a federal, state, and collaborative level.
