Overture Band Programs, Inc. is dedicated to providing instrumental music education and opportunities to students in private, parochial and home schools in Dane County, WI, through quality band programs.

Overture Band Programs, Inc. provided band programs to 16 private, parochial and home school groups in Dane County, WI, that would otherwise be unable to offer and provide instrumental music education to their students. Four hundred sixty-two (462) students from those 16 schools participated in Overture's band programs for the 2011-2012 school year. Music instruction provides students with academic and aesthetic experiences that enhance the quality of their comprehensive education and their lives, and serves as an avenue for creativity, self-awareness and self-expression. Music education also increases a student's self-confidence and positively influences the development of high cognitive processes and enhances one's spatial intelligence.

4b (Code:) (Expenses \$ 5675 including grants of \$ 0) (Revenue \$ 6230)

Overture Band Programs, Inc. offers two summer opportunities for participating students to extend their instrumental music education through the summer. Through more individualized instruction, 17 students from 2 participating schools received 1/2-hour weekly, private lessons from one of Overture's teachers (employees) for five weeks during the summer.

The other summer opportunity offered to participating students is a one-week band camp. Students who participate meet for 3 1/2 hours each day for five days. Their schedule includes a daily assembly, 2 group band rehearsals, 2 music related classes, and the opportunity to learn to play a different instrument for the week. The week concludes with a performance for parents and friends showcasing what the students learned throughout the week. Fifty-one (51) students from 12 schools participated in Overture's Summer Band Camp in June 2011. All four of Overture's teachers (employees) taught at this summer band camp.

4c (Code:) (Expenses \$ 5669 including grants of \$ 0) (Revenue \$ 3660)

Overture Band Programs, Inc. offers its more advanced students the opportunity to participate in Overture's Honor Band and in the Wisconsin School Music Association's District Solo & Ensembles Festival. Sixty-nine (69) students from 11 schools participated in the WSMA District Solo & Ensembles Festival in Feb. 2011, where they prepared instrumental music solos and/or ensembles and performed them for an adjudicator, where they received either a rating and comments, or comments only on their performance (depending on their age). Participation in Solo & Ensembles Festival teaches students to hone their musical skills and to reach a higher level of performance. It also helps students gain poise and self-confidence.

Honor Band provides the students that participate the opportunity to expand their music repertoire, play music that is more challenging (both musically and technically), have a larger group band experience, and perform in seven (7) concerts throughout the school year. Fifty-nine (59) students from 11 schools participated in Overture's Honor Band, where they rehearsed together for 1 1/2 hours once a week for nine weeks each semester. Students who participate in Honor Band share what they learn with their peers in their school bands through the leadership they gain by their participation in Honor Band. A local private high school, where many of Overture's students will attend, allows the Honor Band to use their band room and percussion equipment for rehearsals.
