BUILD, CONSISTING OF OVER 1,600 MILES OF FIBER AND 62 NODE LOCATIONS, BEING 72% COMPLETE. KINBER NEGOTIATED CONTRACTS WITH EQUIPMENT VENDORS AND A NETWORK OPERATIONS CENTER FOR SERVICES RELATED TO RUNNING THE NETWORK. THE INITIAL, GRANT-FUNDED, PENNREN NETWORK BUILD, WILL BE FINISHED IN SPRING 2013. AFTER THIS IS COMPLETE, KINBER WILL CONTINUE TO BUILD THE ROUTE OUT WITH ADDITIONAL FIBER MILES TO CONNECT NEW SITES/MEMBERS TO THE NETWORK.
