	Immanuel Skilled Care Center (DBA) provided 44,333 days of care to its elderly and disabled population. Of that 13,958 were for specialized care in its dementia care unit (Bratsberg Memorial Wing). Services provided to all residents are skilled nursing, assistance with activities of daily living, physical therapy, occupational therapy, speech therapy, social and recreational activities, pastoral services, meals, housekeeping and laundry.

4b	(Code) (Expenses \$ 2,365,170 including grants of \$ 0) (Revenue \$ 3,381,713)
	Buffalo Hill Terrace (DBA), a 100 apartment residential and assisted living facility (expanded to 112 apartments March 2012), had a total census of 35,000 days for the fiscal year which equates to a 93% occupancy. Of the 100 apartments, 45 are licensed for level A and B assisted living services. The assisted living occupancy was 35 for the year with the license increased mid-year. Along with the assisted living services, other services available to all residents are rehabilitative services, social and recreational activities, pastoral services, meals, housekeeping and laundry.

	Care Team Ministry-Mission-"A neighbor's independence depends on you-no one should feel alone." The program was started January 2003 on funding from Robert Wood Johnson Foundation as a national initiative with the intent that these programs after startup would become self-sufficient. Many across the country did not survive because of lack of funding. Ours has survived because it is felt that CTM provides an important service to the community. Funding comes from donations and Immanuel Lutheran Communities. There are no program services revenue generated. The program is a coalition of church and support service agencies collaborating with the healthcare community. Volunteer teams meet short-term, non-medical needs of seniors who desire to remain in their homes, thus enhancing quality of life. Non-medical needs may include transportation to doctor appointments, grocery shopping, minor household chores, phone calls, general outings and companionship. Immanuel Lutheran Communities provides supervision, training and support for the congregational teams. The Care Team Ministry program has about 200 volunteers and serve about 200 individuals annually.
