Havre Day Activity Center, Inc. provided residential services to 38 developmentally disabled adults, day service and shelter work for 46 developmentally disabled adults, supported employment for 1 developmentally disabled adult and community support for 2 developmentally disabled adults. In 2011, the residential service was provided 365 days. Day/work services were opened 255 days in 2011. Case managers and HDAC staff reviewed services provided for each client throughout the year. Clients set personal goals and any changes in client needs are addressed at these meetings. Nursing services were also provided to monitor clients with special conditions and administer medication.
