DURING THE 2011-2012 SEASON, INTERMOUNTAIN OPERA ASSOC. OF BOZEMAN (IOB) PRODUCED TWO FULLY STAGED OPERAS (FIVE PERFORMANCES), ONE SINGLE ACT OPERA AT THE SWEET PEA FESTIVAL FOR THE ARTS, AN OPEN CONCERT, AND THE FIRST ANNUAL OPERA RUN. EACH PRODUCTION INCLUDED EDUCATIONAL OUTREACH ACTIVITIES TO LOCAL SCHOOLS AND THE GENERAL PUBLIC. ON AUGUST 7, 2011, IOB PRESENTED MARK BUCCI'S SWEET BETSY FROM PIKE "A HORSE OPERA" AT THE SWEET PEA FESTIVAL FOR THE ARTS. SWEET PEA IS A WEEKEND LONG FESTIVAL FEATURING VISUAL AND PERFORMING ARTISTS FROM AROUND THE REGION AND NATION. OVER 13,000 PEOPLE ATTEND THE FESTIVAL. THE OPERA PERFORMANCE WAS NARRATED BY MARGARET KOHLER, WITH SOPRANO CATHERINE SAVERY AS BETSY, BARITONE B. J. OTEY AS IKE, AND KENNETH CHRISTENSEN AS JULIUS AND ACCOMPANIST, WITH AN ESTIMATED AUDIENCE OF 500-700. A SECOND PERFORMANCE OF SWEET BETSY FROM PIKE WAS GIVEN IN BIG SKY, MONTANA, ON FEBRUARY 9TH FOR A DINNER THEATER AUDIENCE OF ABOUT 70 PEOPLE. PRIOR TO THE PERFORMANCE THE ARTIST GAVE AN OPERA WORKSHOP AT THE LOCAL SCHOOL. THE OPERA RUN HELD ON OCTOBER 8, 2011, ATTRACTED 115 RUNNERS AND HAD OVER 40 VOLUNTEERS. THERE WERE THREE RACES, THE 1-MILE KIDS RUN, A 10-MILE RACE, AND A 5-K ALONG THE RACE COURSE. EACH WATER STATION HAD A VOCALIST SINGING OPERA ARIAS. THE RACE WAS STARTED WITH A GONG AND NUMEROUS PARTICIPANTS CAME IN COSTUME (FROM VIKING HELMETS, TO FULL OPERA ATTIRE). THE INTENTION WAS TO BUILD ON THE SUCCESS OF THIS FIRST RUN AND MAKE THE ANNUAL EVENT A MAJOR FUNDRAISER FOR THE OPERA. IOB PERFORMED HUMPERDINCK'S HANSEL & GRETEL ON OCTOBER 14 AND 16. OPERA STARS FROM AROUND THE NATION WERE BROUGHT IN TO FILL THE MAJOR ROLES (MEZZO-SOPRANO LAUREN MCNEESE AS HANSEL, SOPRANO AUDREY LUNA AS GRETEL, MEZZO-SOPRANO LISA VAN DER PLEOG AS THE MOTHER AND WITCH, AND BARITONE DARRELL BABIDGE AS THE FATHER. LOCAL ARTIST, SOPRANO ELIZABETH CROY, AS THE SANDMAN AND COLORATURA SOPRANO, TASHA FAIN, AS THE DEW FAIRY), WITH TOP TIER LOCAL MUSICIANS FILLING THE 26 MEMBER ORCHESTRA, 26 CHILDREN IN THE CHORUS, AND 14 MEMBERS OF THE MONTANA BALLET COMPANY PERFORMING THE BALLET SECTION OF THE OPERA. JULIAN DAWSON CONDUCTED THE PRODUCTION WITH ALAN FISCHER AS STAGE DIRECTOR. IN THE TWO WEEKS OF FULL REHEARSALS PRIOR TO THE PRODUCTION, THE GUEST ARTISTS VISITED THE LOCAL HIGH SCHOOL AND UNIVERSITY PERFORMING FOR MUSIC CLASSES AND WORKING WITH YOUNG ASPIRING MUSICIANS. A COMMUNITY CLASS WITH THE CONDUCTOR, ARTISTIC DIRECTOR, AND GUEST ARTISTS WAS GIVEN THROUGH THE UNIVERSITY'S ADULT EDUCATION PROGRAM CALLED WONDERLUST. THE PERFORMANCES AND OUTREACH ACTIVITIES REACHED OVER 3,000 PEOPLE WITH OVER 120 VOLUNTEERS PROVIDING SUPPORT AND PROVIDING EMPLOYMENT FOR 56 PEOPLE. ON FEBRUARY 12, 2012, IOB HELD AN OPERA CONCERT, "BOZEMAN'S GOT OPERA," FEATURING 13 LOCAL OPERA SINGERS PERFORMING VARIOUS OPERA ARIAS AND DUETS ALONG WITH THE UNIVERSITY OPERA WORKSHOP CLASS PERFORMING THE FINALE FROM MOZART'S THE MARRIAGE OF FIGARO. THIS CONCERT ATTRACTED AN AUDIENCE OF 150 PEOPLE. THE SECOND FULLY STAGED OPERA OF THE 2011-2012 SEASON WAS PUCCINI'S MADAMA BUTTERFLY WITH THREE PERFORMANCES, MAY 16, 18, AND 20. GUEST ARTISTS FOR THIS PRODUCTION WERE SOPRANO CYNTHIA CLAYTON AS CIO-CIO SAN (BUTTERFLY), LYRIC TENOR BRIAN JAGDE AS PINKERTON, MEZZO-SOPRANO LAYNA CHIANAKAS AS SUZUKI, BARITONE LEVI HERNANDEZ AS SHARPLESS, TYLER OLIPHANT AS THE BONZE, TENOR DAVID CODY AS GORO, BARITONE FREDERICK FREY AS THE COMMISSIONER, SOPRANO MARGARET KOHLER AS KATE PINKERTON AND BARITONE B. J. OTEY AS YAMADORI, WITH ARI PELTO CONDUCTING AND STEVEN DAIGLE DIRECTING. A 30 MEMBER ORCHESTRA, 21 MEMBER CHORUS, 15 PERSON STAGE CREW AND OVER 150 VOLUNTEERS ROUNDED OUT THE PERSONNEL INVOLVED IN THE PRODUCTION OF MADAMA BUTTERFLY. OUTREACH ACTIVITIES INCLUDED GUEST ARTIST VISITS TO THE LOCAL HIGH SCHOOL AND MIDDLE SCHOOL AS WELL AS A MASTER'S CLASS AT THE UNIVERSITY. SEVEN-HUNDRED 5TH AND 7TH GRADERS WERE BUSSED TO THE PERFORMANCE VENUE FOR A BEHIND-THE-SCENES FIELDTRIP. STUDENTS GOT TO SEE HOW SETS AND DROPS ARE CHANGED, WHAT GOES ON FOR COSTUMING, HAIR AND MAKE-UP, AND HEAR DIFFERENT SINGERS PERFORM AS WELL AS TALK ABOUT SINGING AS A CAREER. THE UNIVERSITY ADULT EDUCATION CLASS, "WONDERLUST," HELD AN OPERA CLASS FEATURING CONDUCTOR ARI PELTO GIVING AN IN-DEPTH LOOK AT THE MUSIC OF MADAMA BUTTERFLY. FORMER OPERA SINGER SUZANNE GORDER GAVE A WORKSHOP ON PUCCINI AND MADAMA BUTTERFLY. PERFORMANCES AND OUTREACH ACTIVITIES SURROUNDING MADAMA BUTTERFLY REACHED OVER 4,000 PEOPLE AND EMPLOYED 92 PEOPLE.
