DATA COLLECTED FROM THE HUNGER SURVEY IS USED TO TARGET MFBN'S OUTREACH ACTIVITIES FOR SNAP (FORMERLY FOOD STAMPS), SUMMER FOOD PROGRAM AND OTHER PUBLIC FOOD PROGRAMS. THE PUBLIC POLICY PROGRAM IS WORKING TOWARD LONG TERM SOLUTIONS TO HUNGER IN MONTANA WITH THE MOST RECENT EMPHASIS ON FACILITATING HOLISTIC COUNTY-LEVEL INITIATIVES.
