 Explanation of grants: 16 students received scholarships for the cost of the GED testing fee @ \$55 each. One student was given a \$1000 scholarship for post-secondary education. The GED testing scholarships were made out to the GED test center so they could not be used for any other purpose. The postsecondary scholarship was made out to the college and the student.

 English Language/Civics instruction for 26 adults seeking to speak English better and to become participants in the community or to gain citizenship.
