Auxiliary Services Food Services Meals are provided at Northwest Nazarene University by Sodexo, Inc. and Affiliates Most students living on campus are required to carry a meal plan Meal plan options are based on the residence hall being lived in Approximately 714 students are enrolled in some type of meal plan on campus Student Housing Northwest Nazarene University maintains seven residence hall facilities on campus with a total capacity for more than 800 students All unmarried students who do not have senior standing or are less than 22 years of age, and who do not reside with parents/guardians, are required to live in one of the residence halls The residence halls are divided into upper and lower division categories On-campus Bookstore Local on-campus and online bookstore serving the needs of students, faculty, staff, parents, and alumni of Northwest Nazarene University The primary goal is to ensure that students are able to obtain the course materials they need at reasonable prices Many other items are also available to support the academic career and school spirit Conferences and Events Handles rentals/planning for events, conferences, camps etc , held in the performing arts center as well as other areas across campus Residential Rentals Over the past several years, the University has purchased various properties that are in the vacinity of campus These properties are to be used, according to the campus master plan, for future expansion of the campus Depending on the condition of the homes on these properties, they have either been demolished or turned into rental properties until such time as they are needed for campus expansion
