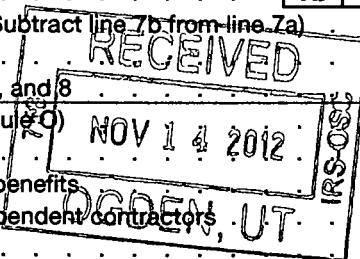

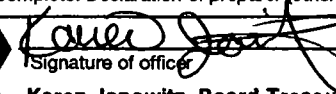

stimulating dialogue and personal growth for young people, their families, and the wider community. In the 2011/2012 season Olympia
Family Theater presented four plays – Animal Farm, Christmas Story, Bunnacula, and Goodnight Moon. Each play was performed at least
four times a week for three weeks. Over the course of 50 performances, Olympia Family Theater entertained over 3500 audience members.
250 tickets were donated as part of our Complimentary Tickets Program to underserved communities and 100 were given to other
organizations for their fundraising efforts. Olympia Family Theater received \$12,720 in donated broadcast advertising for the productions.**

**Part III - Line 29. As part of our mission to encourage personal growth, Olympia Family Theater offered educational and creative drama
camps to over 150 youth. They experienced and participated in sound and movement workshops, monologues, scene work, and put on
theater performances. \$965 in scholarships was provided for youth in-need to attend the camps. Over 25 youth performed in an all-youth
production of the Phantom Tollbooth, which was performed on the "main stage". Over 25 performed in an all-youth production of Stories
Under the Big Top for younger youth. In addition, Olympia Family Theater's "On The Move" program brought short productions to four
elementary schools and the public library, reaching over 800 students. Five monthly daytime performances were performed at the Olympia
Family Theater space, entertaining over 400 youth and parents. Olympia Family Theater received \$2,850 in donated broadcast advertising
for the Phantom Tollbooth.**
