Basic Needs Program - Providing assistance to families in Boulder and Broomfield Counties in need of financial assistance for food, rent, rental deposits, utilities, transportation, emergency motel shelter, medical expenses, mortgage payments, etc. We served 4,540 households in FY12. Clients met with a caseworker, who evaluates their needs and attempts to solve them via referrals, direct payments to vendors, visits to our food bank, or financial advice and budgeting assistance. The Basic Needs Program includes our food bank in Boulder, our furniture donations/distribution program, and basic needs offices in Boulder, Lafayette, and Broomfield. EFAA provided \$691,559 in direct financial assistance for rent, utilities, transportation, emergency motel shelter, minor medical and dental needs, and miscellaneous in FY12. Our food bank distributed 746,547 pounds of food to over 2,830 households; we value this food at \$1.69 per pound, so this amounted to \$1,261,664.

Shelter and Housing Program - Providing emergency shelter and transitional housing to families in Boulder and Broomfield Counties which are at risk of homelessness.
Emergency Shelter Program - Families which are are homeless or nearly so when we encounter them are housed in one of our shelter units for up to three months. During their stay, we provide all living expenses and safeguard the clients' income for them so when they leave they have savings to arrange for housing. Some of our emergency client families are accepted into our Transitional Housing Program. Emergency shelter clients meet with a caseworker at least weekly.
Transitional Housing Program - Families are housed in one of our transitional housing units for up to two years. During their stay, they pay a security deposit and below-market rent. Ideally, when they move out, they have saved enough to secure more permanent housing solution, and have experienced success at being good tenants.
EFAA has 57 units of shelter and housing in Boulder, Lafayette, Longmont, and Louisville. In FY12 we served 126 households representing 437 individuals. 88% of families leaving these programs found affordable housing, considered a successful outcome.

Line 16b - EFAA raises most of its operating revenue from donations, contributions, grants, and other public support. To make this happen, we have a full-time Director of Development, Fundraising Database Coordinator, and part-time Event and social Media Coordinator. We also incur expenses for newsletters, mailings, postage, printing and outreach.

Line 19 - Generally, EFAA's annual budget is break-even before depreciation of buildings, which are purchased via capital campaigns. In fiscal year 2012, the \$509,594 surplus was because of \$546,075 of Boulder County Worthy Cause funding used to help purchase a fourteen unit apartment building in Louisville, CO.

Part IV, Line 10 - EFAA holds a Board restricted endowment in the name of Abigail Greer to help support our children's program.

Part VI, Line 8b - On occasion, the Executive Committee of the Board is authorized to act on behalf of the Board. Minutes are not kept, but the actions of the Committee are reported at the subsequent Board meeting and recorded in the Board's meeting minutes.

Part VI, Line 12c - The Executive Director monitors compliance of EFAA's written conflicts of interest policy. Conflicts which are discussed at the Board level are documented in the minutes.

Part VI, Lines 15a and 15b - A volunteer HR professional annually compiles industry comparable salary data for EFAA positions. For all positions other than the Executive Director, with assistance of the management team, reviews compensation ranges and makes changes as needed. For the Executive Director, the Personnel Committee of the Board collects Board and staff input and recommends changes to the Executive Director's contract as needed; the full Board reviews and discusses these recommendations prior to approval in Executive session.
