

 During the fiscal year ending 6-30-12, Project Self-Sufficiency assisted 186 single parents during all or part of that 12 month period. Each program participant was matched with an advisor from the PS-S staff who helped with goal setting, career planning, problem solving, resource acquisition, access to further education, counseling, and job search for those who are ready. Expenses to provide these services included, salaries and benefits for program staff and program management, as well as supplies, postage, printing, office space, and other expenses related to program operations. Additional expense related to program activities and resources that address barriers to self-sufficiency are included in other categories below. See the annual program report at [www.ps-s.org](http://www.ps-s.org) for further information. Look in the "Who We Are" section for reports.

**4b** (Code: ) (Expenses \$ \$300,119 including grants of \$ \$290,772 ) (Revenue \$ 0 )  
 To assist families in addressing urgent needs and removing barriers to self-sufficiency Project Self-Sufficiency provides emergency funds and other assistance. To improve family functioning the program offers parenting and self-esteem classes. Children benefit from opportunities to take classes such as music lessons and gymnastics that are paid for through the Boundless Children's Fund. Each year back-to-school clothing is provided for the children. Holiday programs are offered each December.

Scholarships for single parents enrolled in the program help pay for academic expenses, child care while parents are in class, and other needs related to the ability of parents to attend classes and prepare for living wage employment.

**4c** (Code: ) (Expenses \$ \$176,199 including grants of \$ \$104,464 ) (Revenue \$ 0 )  
 The Cars for Families program provides donated vehicles to some families enrolled in the Project Self-Sufficiency program. Donated cars are safety inspected and often repairs are made. Car titles are transferred from the donors to the organization and then to the families who are selected to receive a car. Volunteer and donated car repair is also available to families.

The values of donated vehicles during the fiscal year ended 6-30-12 was \$67,631 and is included as an expense in this section and also as an expense in Part IX 2a and 2b. PS-S shows this value as income as well as an expense since the cars are awarded to families and are not sold for operating income. Also included is the cost of repairs that could not be done by volunteers. This total is \$xxx and the funds come from multiple assistance funds available through Project Self-Sufficiency.

The dollar amount listed here for grants is the value of donated vehicles that were awarded to families and the cost of car repair. Other costs were operational in nature.

4. Part VI. Item 15. Determination of salaries for staff. Every three years the staff gathers comparables on similar positions in the for profit, nonprofit, and governmental sectors. These are submitted to the board for review. If indicated, salary ranges for staff may be altered.

Salary ranges have not changed for a number of years and only one pay increase within those ranges has occurred in the last four years.

The Executive Director's performance is reviewed by the board annually and decisions made about any pay changes. The Executive Director reviews the performance of the rest of the staff and makes pay changes based on the budget and salary ranges when funds are available.
