CHILDREN'S RESOURCE CENTER- ZAMBIA: THE CRC IS AN ORPHAN CARE CENTER DESIGNED TO SERVE AS A TRANSITIONAL RESIDENCE FOR CHILDREN FOUND LIVING IN CHILD HEADED HOUSEHOLDS OR ON THE STREETS. OUR PURPOSE IS TO ADDRESS THEIR PHYSICAL, SOCIAL, EMOTIONAL AND EDUCATIONAL NEEDS, AND PROVIDE A LOVING ENVIRONMENT FOR THESE CHILDREN. IN MOST CASES THEY HAVE UNDERGONE TREMENDOUS LOSS AND ARE EXPERIENCING SERIOUS HEALTH PROBLEMS AS A RESULT OF MALNUTRITION AND NEGLECT.
