FAMILY SUPPORT SERVICES. THE FAMILY SUPPORT SERVICES AND PARENT EDUCATION PROGRAM WORKS CLOSELY WITH FAMILIES TO ADVANCE GOALS ON FAMILY STABILITY, ESPECIALLY FOR HOUSING AND INCOME SUPPORT BY WHICH THEY BECOME CONTRIBUTING MEMBERS OF OUR COMMUNITY. A FORMAL REFERRAL PROCESS IS USED FOR HOUSING, PHYSICAL AND BEHAVIORAL HEALTH NEEDS, DEVELOPMENTAL SERVICES, FINANCIAL ASSISTANCE, EMPLOYMENT AND EDUCATION SUPPORT THROUGH COLLABORATION WITH COMMUNITY ORGANIZATIONS. SIXTY-SEVEN (67) FAMILIES WERE SERVED DURING THE FISCAL YEAR. ENROLLED FAMILIES ATTENDED WEEKLY PARENT EDUCATION CLASSES FOCUSED ON THREE AREAS: PARENTING SKILLS, WELLNESS AND NUTRITION, AND LIFE SKILLS. 75% OF OUR FAMILIES HAD PERMANENT OR TRANSITIONAL HOUSING UPON EXITING OUR PROGRAM.

CHILDRENS SERVICES. CUIDANDO LOS NINOS PROVIDES HIGH-QUALITY, NATIONALLY-ACCREDITED EARLY CHILDHOOD EDUCATION FOR CHILDREN 6 WEEKS TO 5 YEARS OLD WHOSE FAMILIES ARE EXPERIENCING HOMELESSNESS. CUIDANDO OPERATES ON A DAILY BASIS, MONDAY THROUGH FRIDAY FROM 7AM TO 5:30PM. PROGRAM SERVICES ADDRESS THE UNIQUE NEEDS OF THIS POPULATION WITH INDIVIDUALIZED CURRICULUM, BREAKFAST, LUNCH AND A SNACK, TRANSPORTATION TO AND FROM THE CENTER AS NEEDED, THERAPEUTIC CARE FOR CHILDREN AND THEIR FAMILIES, FAMILY MEDICAL CARE THROUGH A HEALTH CLINIC ON SITE. A TOTAL OF 99 CHILDREN RECEIVED SERVICES DURING THE YEAR.

ADVOCACY SERVICES. CUIDANDO LOS NINOS IS COMMITTED TO BEING A COMMUNITY LEADER AND ADVOCATE FOR SOCIAL CHANGE TO END CHILD AND FAMILY HOMELESSNESS. OUR ADVOCACY PROGRAM AIMS TO ENSURE A HOME FOR EVERY CHILD IN NEW MEXICO BY RAISING PUBLIC AWARENESS REGARDING CHILD HOMELESSNESS, CREATING COMMUNITY NETWORKS OF SUPPORT FOR VULNERABLE CHILDREN AND FAMILIES, AND INFLUENCING STATE AND LOCAL POLICIES AND PROGRAMS. CUIDANDO LOS NINOS HAS BEEN AWARDED A YEAR-LONG MEDIA CAMPAIGN TO ADDRESS FAMILY HOMELESSNESS INCLUDING TV COMMERCIALS, RADIO SPOTS, AND DIGITAL BILLBOARDS. A SESAME STREET-TYPE CHARACTER, "LENORD", PRESENTS THE HARSH FACTS ABOUT CHILDREN WHO ARE HOMELESS. THE "YOUTH CREATING CHANGE FILM & ART FESTIVAL" WAS HELD IN MAY 2012. EACH YEAR, MIDDLE AND HIGH-SCHOOL STUDENTS SUBMIT SHORT FILMS ABOUT CHILD AND FAMILY HOMELESSNESS TO RAISE AWARENESS AND ENCOURAGE COMMUNITY ACTION. SEVENTY-FIVE (75) PARTICIPANTS FROM FIVE SCHOOLS SUBMITTED 25 FILMS. OVER 300 PEOPLE ATTENDED THE FESTIVAL.
