Goodwill Industnies of Southern Arizona, Inc provides educational training and support services to increase employability of individuals with barriers to employment through community-based facilities 9,082 persons were served through these educational and training programs and 3,468 people were served at five Job Connection Centers located at the retail store sites Other valuable services include youth mentoring, literacy programs and crisis intervention in partnership with other charities Highlights of these services include Goodwill's state-of-the-art Job Connection Centers provide job search assistance including career planning, resume development, assistance in conducting an internet job search, interview skills training, and referral to appropriate job openings (Continued at Schedule O) All services at the centers are free of charge and no appointment is necessary Goodwill's Job Connection Centers also provide referrals to other community support services including family counseling, day care assistance, ESL or GED training, financial literacy training, tax filing assistance, and food boxes Visitors to Goodwill's Job Connection Centers can build a resume, apply for jobs online, search the community job postings board, and learn about training and other educational opportunities available in Southern Arizona Goodwill's Ready-To-Earn Computer/Customer Service Training is a program specifically designed to provide individuals with the entry-level skills needed for successful employment in Tucson's Call Center Industry with starting wages of \$8 00 - \$12 00 per hour The Ready-To-Earn Training Program is highly respected by area employers and has won three national awards This program is accredited under CARF-the Commission on Accreditation of Rehabilitation Facilities-Employment Skills Training and licensed by the Arizona Board for Private Postsecondary Education Goodwill's Morse Job Opportunity Center provides paid work and sheltered employment services for adults with disabilities who are too severely disabled to work in other locations in the community Goodwill's Job Opportunity Center provides these individuals with the protected/safe work environment in which they receive the support they need and "real pay for real work" The services provided through Goodwill's Job Opportunity Center are accredited under CARF-the Commission on Accreditation of Rehabilitation Facilities-Organizational Employment Individuals participating in Goodwill's Job Opportunity Center must be referred and supported by the State of Arizona - Division of Development Disabilities (DES-DDD) or the State of Arizona - Rehabilitation Services Administration (DES-RSA) Goodwill Youth Mentoring is an exciting and innovative program to help at risk youth build career plans and skills, prepare for school completion, post-secondary training and productive work by providing structured and supportive relationships with trusted adult mentors It targets young people between the ages of 12 and 17 who are at-risk for dropping out of school, facing legal troubles, or are at risk for delinquency due to issues such as abuse, disability, drug or alcohol dependence, or gang membership We also support the families of enrolled youth by providing community resource information, job search assistance and other support as needed

	Part I, Line 4b	Suzanne Lawder has been employed by Goodwill Industries of Southern Arizona, Inc. (GISA) for 31 years. She has served in her current capacity as President and CEO for 26 years. She assumed the responsibility of President/CEO when GISA was faltering and on the verge of filing for bankruptcy. In line with current best practices, the GISA Board, in 2009, hired an independent compensation consultant who reported that Ms. Lawder's compensation remained below comparable compensation being paid other not-for-profit top executives in the Tucson Metro area. Of further concern was GISA's commitment to Affirmative Action and the fact that the other executives, with like organizations, were all male. Ms. Lawder continued in her position for many years without retirement and other benefits accorded to CEOs in similar positions in the Tucson area. To address this situation, a company specializing in "catch-up" clauses was retained. After almost a year of working with the outside consultant on the above issue, the Board approved, under the recommendation of the Compensation Committee, a retirement "catch-up" clause with the purpose of back-paying retirement benefits by including a 457(b) and an After Tax Savings Program in Suzanne's current employment agreement. In fiscal year ended June 30, 2012, \$16,500 was contributed to the 457(b) plan and \$214,624 was contributed to the After Tax Savings Program.
