EMERGENCY SHELTER SERVICES FOR HOMELESS SINGLE ADULTS PROVIDES FOR THE BASIC NEEDS OF HOMELESS ADULT MEN AND WOMEN. SERVICES INCLUDE SHELTER BEDS, SHOWERS, ACCESS TO FOOD, CLOTHING AND HYGIENE ITEMS. ALL SERVICES ARE PROVIDED TO HOMELESS RECIPIENTS AT NO COST. CASS PROVIDED 157,617 NIGHTS OF LODGING TO 3,714 UNDUPLICATED MEN AND WOMEN. CASS HAS 43 BEDS SET ASIDE FOR ELIGIBLE HOMELESS VETERANS IN THE CASS VETERANS GRANT PER DIEM PROGRAM. IN ADDITION TO THE DESIGNATED BEDS, CASS PROVIDES SUPPORTIVE SERVICES TO PARTICIPATING VETERANS AND COORDINATES SERVICES WITH THE VETERANS ADMINISTRATION MEDICAL CENTER. THE CASS VETERAN GRANT PER DIEM PROGRAM PROVIDED 14,708 NIGHTS OF LODGING TO 181 HOMELESS VETERANS. IN ADDITION TO SHELTER, CASS ALSO PROVIDES SUPPORTIVE SERVICES INCLUDING CASE MANAGEMENT AND EMPLOYMENT SERVICES TO ASSIST CLIENTS IN ENDING THEIR HOMELESSNESS. CASS CASE MANAGEMENT PROVIDED 8,063 HOURS OF CASE MANAGEMENT SERVICES TO 2,555 SINGLE ADULTS. CASS EMPLOYMENT SERVICES PROVIDED JOB READINESS, EMPLOYMENT COUNSELING AND ASSISTANCE AND JOB PLACEMENT TO 982 INDIVIDUALS.

TO MEET OVERWHELMING DEMAND FOR SHELTER, CASS ALSO OPERATES AN OVERFLOW SHELTER FOR SINGLE ADULT MEN UNABLE TO ACCESS THE CASS EMERGENCY SHELTER DUE TO LACK OF CAPACITY. SERVICES ARE LIMITED TO BASIC OVERNIGHT SHELTER AND BATHROOMS. OUTREACH SUPPORTIVE SERVICES ARE AVAILABLE TO PROVIDE REFERRALS TO CASS AND OTHER SERVICES LOCATED AT THE HUMAN SERVICES CAMPUS. THE OVERFLOW SHELTER PROVIDED 68,323 NIGHTS OF LODGING TO 3,875 UNDUPLICATED SINGLE ADULT MEN.

CASS PROVIDES EMERGENCY SHELTER TO HOMELESS FAMILIES THROUGH THE VISTA COLINA EMERGENCY FAMILY SHELTER (VISTA COLINA). SERVICES INCLUDE ACCESS TO BEDS, SHOWERS, FOOD, CLOTHING AND HYGIENE ITEMS. VISTA COLINA PROVIDED 39,711 NIGHTS OF LODGING TO 710 FAMILY MEMBERS OF 208 FAMILIES INCLUDING 415 CHILDREN. VISTA COLINA ALSO PROVIDES SUPPORTIVE SERVICES TO ASSIST FAMILIES IN ENDING THEIR HOMELESSNESS AND REGAINING THEIR SELF-SUFFICIENCY. TO THIS END, VISTA COLINA CASE MANAGERS PROVIDED 1,305 HOURS OF CASE MANAGEMENT SERVICES TO 295 ADULT FAMILY MEMBERS TO ENHANCE PROSPECTS OF FAMILY STABILITY SUCH AS INCOME, HOUSING AND OTHER RESOURCES. VISTA COLINA ALSO PROVIDES AN ACCREDITED CHILD CARE PROGRAM TO ENSURE THAT PRE-SCHOOL AGED CHILDREN HAVE A SAFE SETTING TO ENABLE PARENTS TO ADDRESS THE FAMILY’S GOALS. THE VISTA COLINA CHILD CARE PROGRAM DELIVERED 28,671 HOURS OF CHILD CARE TO 171 PRE-SCHOOL AGED CHILDREN. AFTER-SCHOOL PROGRAMS ARE ALSO PROVIDED FOR SCHOOL-AGE CHILDREN. THESE PROGRAMS PROVIDED 6,520 HOURS OF SERVICES TO 188 SCHOOL-AGED CHILDREN.

THE CASS DENTAL CLINIC PROVIDES COMPREHENSIVE DENTAL TREATMENT & CARE AT A STATE-OF-THE-ART 9-CHAIR FACILITY AND UTILIZES THE SERVICES OF AN EXTENSIVE CADRE OF DENTAL VOLUNTEERS AND DENTAL LABS FROM THROUGHOUT THE U.S., AS WELL AS COLLABORATIVE RELATIONSHIPS WITH THE LOCAL DENTAL COMMUNITY TO CREATE A NATIONALLY RECOGNIZED COMPREHENSIVE DENTAL EFFORT. PROGRAM RECIPIENTS PAY NO FEES FOR SERVICES. PROGRAM PARTICIPANTS RECEIVE PAIN RELIEF AND INFECTION CONTROL, DENTAL HYGIENE, ORAL HEALTH EDUCATION, AND CAN BE ELIGIBLE FOR FULL RESTORATIVE DENTAL CARE WHEN CASEPLAN COMPLIANT. THE CASS DENTAL CLINIC PROVIDED SERVICES TO 1,160 AND PROVIDED ALMOST 13,900 UNITS OF SERVICE DURING THE YEAR. THESE SERVICES WERE VALUED AT OVER \$2,176,603. OTHER PROGRAMS INCLUDE VOLUNTEER SERVICES AND PROGRAM MANAGEMENT OF OTHER ORGANIZATIONS.
