	UFB provides food to over 225 partner agencies so they can focus on direct services (sheltering, youth and senior services, residential and rehabilitation facilities, counseling, job training) In partnership, we feed over 880,000 unduplicated individuals in one year by providing the food needed for about 45,000 meals a day - 365 per year UFB provides direct food through Kid's Caf�� (so children can receive nutritionally balanced evening meals five days a week to at-risk kids), Backpack Program (providing food to kids who miss meals over the weekend), and Help Yourself (for working poor to purchase discounted food to help stretch their dollar) United Food Bank also provides direct services in the form of Helping Hands (a resource for those "First Responders" who find a family or household without food or immediate food resources), Food For Thought (a program that connects educators with us to help children reach goals and overcome difficulties in school), and the annual Citrus Gleaning Program (where area volunteers harvest local citrus trees for donation to the hungry) In addition, United Food Bank hosts hundreds of people every year who are apart of community, business, faith, and government groups to volunteer in our facility and to host a food drive For many, the food drive is the first way to engage and help your neighbor in need At UFB, we aim to make that experience an easy and enjoyable one - so people want to do it again!
