In FY2011-12, Interfaith Community Services provided 55,934 services to 25,477 individuals with the help of 45,016 volunteer hours. The services include Health Advocacy (education and advocacy for seniors and disabled); Caregiving Services (transportation, shopping, business help, minor home repairs, and personal visits for seniors and disabled); Mobile Meals (delivery of two meals per day, 5 days per week); Food Bank (distribution of food to low income clients) Emergency Financial Assistance (rent, utilities, medications, school supplies, etc. for low income clients); Income Tax Assistance (preparing and filing federal and state income tax returns for low income clients); and Resource Center (employment assistance, job coaching, and financial literacy for low income clients).
