ARM HAS DEVELOPED 140 UNITS OF AFFORDABLE HOUSING FOR THE PURPOSE OF PROVIDING HOUSING AT BELOW FAIR MARKET RENT TO FORMERLY HOMELESS/LOW INCOME HOUSEHOLDS TO HELP THEM STABILIZE AND MAINTAIN THEIR SELF-SUFFICIENT LIFESTYLES. ARM HELPS LOW-INCOME RENTERS BY DEVELOPING AND MANAGING AFFORDABLE HOUSING UNITS THAT ARE SO URGENTLY NEEDED. ARM PROVIDES A VITAL LINK IN THE CONTINUUM OF SERVICES TO ALLOW FORMERLY HOMELESS HOUSEHOLDS TO MOVE FROM A TRANSITIONAL SETTING TO MORE PERMANENT AFFORDABLE HOUSING, WHILE CONTINUING TO ACCESS SUPPORTIVE SERVICES TO HELP THEM STABILIZE AND MAINTAIN THEIR SELF-SUFFICIENCY DURING FISCAL YEAR 11-12, ARM SERVED 140 HOUSEHOLD CONSISTING OF 473 ADULTS AND CHILDREN. 75% OF HOUSEHOLDS SERVED DURING (CONT'D ON SCH O) FY 11-12 CAME FROM THE CITY OF MESA. 82% OF HOUSEHOLDS SERVED EARNED BELOW 50% OF AREA MEDIAN INCOME (AMI), 14% EARNING UNDER 30% OF AMI AND 18% OF HOUSEHOLDS EARNED BELOW 80% OF AMI. 71% OF THE HOUSEHOLDS SERVED IN ARM MAINTAINED THEIR LEASE AGREEMENT LONGER THAN A YEAR. 21% PERCENT OF HOUSEHOLDS INCREASED THEIR INCOME WITHIN ONE YEAR OF ENTRANCE INTO ARM. FINALLY, DURING FISCAL YEAR 11-12, 64% OF FAMILIES' LIVING WITHIN ARM PARTICIPATED IN SERVICES PROVIDED THROUGH THE COLLABORATION WITH SAVE THE FAMILY'S FAMILIES, ADULTS, AND CHILDREN'S EMPOWERMENT SERVICES-FACES EMAILED TO EACH BOARD MEMBER PRIOR TO MONTHLY BOARD MEETING WHERE IT WILL BE APPROVED. EVERY NEW BOARD MEMBER IS GIVEN AN ORIENTATION, AND THE CONFLICT OF INTEREST POLICY IS REVIEWED AND SIGNED OFF BY THEM. ON AN ANNUAL BASIS THE FORM IS RESUBMITTED TO ALL BOARD MEMBERS.
