Program strategies include: rehabilitation of owner-occupied distressed housing, rehabilitation/replacement of foreclosed properties, and development of new single family homes on vacant lots. These homes are sold to first-time homebuyers who have received their Certificate of Completion of Homebuyer Training. Primavera also works with families who purchase Primavera homes in the City of South Tucson by installing water harvesting systems and sustainable landscaping and providing training in maintenance of these systems.
