	This year SaddleBrooke Community Outreach SBCO celebrated its fifteenth birthday In April the general meeting was devoted to our history and included many of our initial members who told stories about our beginnings SBCO also became aware of the need to relocate Kids Closet The Gardner Learning Center could no longer be maintained by the MammothSan Manuel School District Copper wiring had been stolen from the building lightning caused power failures and a small flood in a low r warehouse area damaged our merchandise Working with a local realtor and the Mammoth Town Council SBCO was able to lease a 2 acre parcel of land between the STEM Mammoth Elementary School and Highway 77 That lease is for 30 years at 1 per year TB Contractors in Catalina was hired for the construction of a metal 12000 square foot building that would house all the warehouse needs the closet area for selecting clothes and a divisible area for children to await their turns in the cl oset The bright red building was erected in a few months and students from the STEM school were able to visit the site throughout the spring semester gaining new knowledge for their classroom studies Home DepotOro Valley teamed with us to build shelving dressing rooms and areas for hanging items They provided the material and labor saving us thousands of dollars The SaddleBrooke Fine Arts Guild painted the walls with desert critters and 5 cactus plants representing levels of gifti ng in a spring fund raiser Much of the paint was donated by Home Depot That spring fund raiser was designed to help finish the interior of the building Kids Closet opened in August 2011 for uniform dispersal to MammothSan Manuel students regular days for other students began in September The closet then closed for the academic year in April 2012 Each of two semesters provided underwear sneakers 3 pairs of pants & shirts hygiene items and books Fall included a windbreaker Bo ys could select a baseball cap and belt girls could have a skirt or dress The average cost of a seasonal wardrobe was 70 In 15 years we have provided 24462 children with 33727 wardrobes Number of wardrobes 3049 Number of unduplicated students 2037 Teen Closet our program for high school students in Pima County took place in July with 32 teens purchasing school-appropriate clothes at Target and Ross For Less Another group of 17 had a follow-up shopping trip in January Each teen had an SBCO volunteer who helped the shopper remain within a budget and stick to the school dress code Since 2002 Teen Closet has provided 286 wardrobes Enrichment programs primarily took place in July and included arts programs a t Rancho Linda Vista in Oracle College for Kids in Araviapa swimming lessons in San Manuel a Pre-K special needs program in MammothSan Manuel school district a library book program at Ray Elementary School and another reading program in Kearny An additional enrichment program was a National Junior Honor Society trip to Washington DC and New York City We also support the Triangle Y summer camp program in Oracle and a teen program called Ten for Teens where youngsters volunteer 3 ho urs a week at the Family First Pregnancy Center in Oracle or Winkelman One gifted student attended the ASU Barrett Summer Scholars program in June These activities served 429 youngsters College scholarships were being used by 15 gra duates attending U of A 1 at ASU 4 at Pima Community College and 3 Central Arizona College Since 2001 we have granted 133 scholarships to trade schools community colleges and universities Our education program provided stipends to U of A students who tutored at Coronado Elementary School We also provided funds to purchase needed workbooks for Coronado More than 120 adults tutored youngsters in 4 school districts The 15th annual Walkathon in October had 409 registrants A b reakfast buffet was well received and a number of items were raffled off to participants Registration fee included a special T-shirt and breakfast A running slide show featured walkathons from past years The Grand Marshal was Florence Madas at age 94 she represented the spirit of volunteerism November was the time for Thanksgiving food baskets People donated many canned items making it possible to devote money to the purchase of turkeys rolls and fresh fruit Twenty five comple te baskets were delivered to San Pedro Behavioral Health Clinic in Oracle Since 1999 we have delivered 210 baskets Expenses were 100000 Adopt A Family headed by Ken & Ellen Perkins distributed Christmas gifts to 243 children on the San Carlos Apache Indian Reservation and 88 families in the Tri-Communities area This program involves giving names and gift information to interested adopters and has no expense to SBCO Since 1998 SBCO has provided Christmas to 651 families and
