Volunteer Resources

The Volunteer Resources program offers volunteer support to all areas of SAAF in addition to providing vital outreach to the community. Since its earliest beginnings, SAAF has relied on volunteers to provide much-needed client services as well as prevention outreach. This still holds true today.

Volunteers are given training, continuing education, and staff support to acquire the skills needed to take on these important roles throughout the agency. VR provides monthly orientations to new volunteers, as well as quarterly advanced trainings. Volunteers made an impact by helping to support a healthier community through advocacy, outreach, and support.

Almost 1,300 volunteers provided more than 11,000 hours, which equates to approximately \$249,000, according to the IndependentSector.org and the Bureau of Labor Stats.

Care Services

Care Services ensure that people living with HIV/AIDS have access to the services they need to maintain optimal health and live as independently and safely as possible. Care Services are grouped into three areas: clinical, support, and housing services.

Of all the people served last year, 96% were low income, with 54% living below the poverty level. People facing the increased challenge of living with HIV/AIDS while living below poverty level included 72% of the women served by SAAF and 63% of those who were new to SAAF during the year. Due to the ongoing economic conditions and the stress of living with limited incomes, the number of people who received housing and food services increased. The demand remained high for other basic support services including transportation, emergency rent and utility assistance, as well as essential medical services including dental care and medications assistance.

Once again, SAAF provided services to the greatest number of people in its history, serving 1,117 people living with HIV/AIDS and their household members. Of these, 125 were new clients to SAAF.

Clinical Services

- Case Management provided needs assessments, the development of care and action plans, and provision of or referral to necessary services.
- Peer Counseling provided people living with HIV/AIDS with a caring person living with or deeply affected by HIV/AIDS, from whom they can receive support and information.

Support Services

- Dental Services (provided statewide except for Maricopa and Pinal Counties)
- Food and Nutrition Services, including the Food for Life Program and the Food Pantry
- Holiday Project
- Medical Benefits cost sharing assistance for those enrolled in statewide ADAP Assist
- Medications Assistance
- Support Groups
- Transportation Services
- Wellness and Buyers' Club
- Other personal support services

Housing Services

- 83 units owned by SAAF at seven different locations
- 90 subsidized rental units in the community
- Move-in assistance and short-term financial assistance to help pay rent, mortgage, and utility bills

Through your support SAAF was able to offer a comprehensive array of services that made a great impact for many people last year.

- 1,106 people received case management and peer counseling services
- 577 people accessed dental services through a contract with Delta Dental
- 523 people received food assistance
- 484 people received assistance with medical costs through ADAP Assist
- 442 people received transportation services
- 222 people received assistance through the Holiday Project
- 220 people received medications assistance
- 212 people received emergency short-term rent, mortgage, and utility assistance or move-in deposits
- 103 households lived in SAAF properties, housing 137 people
- 102 households lived in SAAF tenant-based subsidized units, housing 199 people
- 54 people accessed services of the Complementary Therapies Program

Prevention Services

SAAF's Prevention Department creates healthier communities through innovative education, training, and outreach services to reduce the transmission of HIV, Hepatitis, and Sexually Transmitted Infections by using safe and supportive approaches. Prevention services targeted populations at increased risk of HIV infection or transmission, substance use, and suicide. Communities served included gay/bisexual men and other men who have sex with men (MSM); men and women who inject drugs, have a history of injection drug use, are currently in drug treatment, and/or have a history of incarceration; youth, including young people of color, LGBTQ youth, and adjudicated youth; and people living with HIV/AIDS. In fiscal year 2012 services were expanded in the areas of HIV rapid testing in Cochise County. SAAF now provides HIV testing services in nine of the fifteen counties in Arizona covering a geographic area of 43,221 square miles.

SAAF successfully completed four grants from the Arizona Department of Health Services during the fiscal year. MSHAPE (Men's Sexual Health and Personal Empowerment), a 5-year grant targeting gay/bisexual men; HIP/AZ (HIV Intervention & Prevention – Arizona), a 5-year grant targeting people living with HIV/AIDS, their partners, and other high-risk negatives in the Tucson, Phoenix, and Yavapai County areas; state-funded components of our Alternatives program targeting injection drug users; and M2M (Man-2-Man), a 5-year collaboration with Southwest Center for HIV/AIDS that provided weekend seminars on holistic health for MSM. All four programs showed positive outcomes, provided support to hundreds of participants, and had long lasting impacts in our community.

SAAF continues to provide effective behavioral interventions that include health education and risk reduction activities such as outreach, individual-level interventions, group-level interventions, community-level interventions, and health education/public information; and Public Health Strategies such as Comprehensive Risk Counseling Services (CRCS), HIV Counseling, Testing and Referral Services (CTRS), and Syringe Access Services.

Prevention programs conducted over 550 outreach and educational events, making over 22,500 contacts; 294 participants received individual level interventions, including syringe access services, with over 900 sessions conducted; and 60 group level interventions were conducted reaching 820 individuals.

HIV Counseling and Testing is provided by SAAF staff in collaboration with the Pima County Health Department. Testing is available at SAAF, behavioral health agencies, local bars, and at community events throughout the year. Confidential HIV testing using a HIV Rapid Test is available. Last year approximately 1,953 people received HIV rapid testing services at SAAF, Behavioral Health Agencies in Yuma, La Paz, Gila, Pinal, Cochise, Graham, Greenlee, and Santa Cruz counties, community locations, and at mobile-testing events.

SAAF also started a new Hepatitis C Rapid Testing initiative targeting people who inject drugs or have a history of substance use and/or incarceration. Hepatitis C rapid testing services were provided to 60 people.
