Form 990, Part VI, question 11a - The 990 form and related schedules are reviewed by separate Directors before signing. The Board of

Directors are subsequently given a copy at the next regularly scheduled meeting for their records.

Form 990, Part VI, question 15a, 15b - The Executive Director's salary is reviewed by the President of the Foundation. After that review is  
completed for the current year a revised salary is documented in their personnel file for the current salary. The Executive Directors salary  
and other employees salary are based on comparable salaries within the local market.

Form 990, Part VI, question 19 - The Foundation makes available for review the financial statements, State of Arizona Department of Revenue  
reports along with State Corporation filings. On the Foundation web site we have a statement notifying constituents that reports are  
available upon request. If we have had a request the Foundation has provided them.
