Education - Seeks to increase awareness about colorectal cancer and educate the public about the importance of early detection and survivorship issues through a variety of campaigns and educational materials

Awareness - The Alliance has 2 signature awareness programs: the Undy 5000 & Dress in Blue Day. The Undy 5000, a 5 kilometer road race, was held in 4 cities and seeks to raise colorectal cancer awareness by having participants wear blue boxer shorts. Dress in Blue day takes place the first Friday of March and encourages individuals, businesses, and community groups to participate by wearing blue.

Conferences - The Alliance hosts regional seminars for newly diagnosed, advanced disease patients, long-term survivors, caregivers and friends, nurses, and other healthcare professionals. Each seminar includes the most up-to-date colorectal cancer treatment information from leading colorectal cancer healthcare professionals and forums for peer-to-peer support.

Chapters - The Alliance's volunteer program gives advocates an opportunity to use their voices to help the Alliance succeed in its mission. Voices volunteers serve as liaisons to the Alliance's national office and lead colorectal cancer efforts in their community. The Alliance provides volunteers the support and services they need to educate their community about colorectal cancer awareness and screening.

(Code) (Expenses \$ 240,334 including grants of \$) (Revenue \$)

Connections Campaign - Offers information and support for patients, their families and friends. These services are provided through the website, toll-free helpline, Buddy Network and Chat.

Community Health Grants - The Colon Cancer Alliance (CCA) has launched the Community Health Partnership Grant Program in order to provide funding to partners who will help further its mission to provide hope and support to patients and their families, while saving lives through screening, access, awareness, advocacy and research. The CCA will partner with an organization, company or individual who provides services that promote screening access, provides treatment access, and/or conducts research that advances quality of life concerns and addresses barriers to screening.
