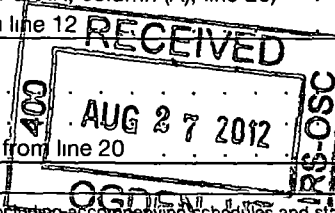

 Orchestral Training Program - For over 50 years, PYS programs have provided music education and instrumental and performance training of the highest quality to Phoenix metropolitan area youth. Musicians are selected by audition to participate in a "stair-step" training program that currently consists of five ensembles (Youth Symphony Orchestra, Symphonette Orchestra, Symphonic Winds Ensemble, String Orchestra and Percussion Ensemble).

4b (Code:) (Expenses \$ 31,908 including grants of \$ 17,388) (Revenue \$ 14,897)
 Young Musicians Competition ("YMC") - PYS sponsors an annual musical competition that is open to all non professional music students who reside in and attend school in grades 6 through 12 in the state of Arizona. Senior Division winners of YMC are awarded scholarships to national music camps and the two top winners perform concertos with Phoenix's professional orchestra, The Phoenix Symphony. Junior Division winners are awarded cash prizes.

4c (Code:) (Expenses \$ 25,676 including grants of \$) (Revenue \$ 21,003)
 Music Memory - This service is a cultural enrichment program designed to enhance the understanding and appreciation of symphonic music. It is designed primarily for elementary school children in grades 3-6 and is open to all schools in the Greater Phoenix area. Each year, the musical pieces to be studied are selected by the PYS Youth Symphony music director and the PYS program committee prepares a listening guide that is provided to the classroom teacher for study prior to the performance of a concert by the Phoenix Youth Symphony Orchestra that features the selected music.
