WOMEN IN JEOPARDY - A temporary refuge for women and children who are victims of family violence, a place where residents can obtain immediate safety and support, feel welcome and respected, gain access to community resources, and become more empowered to create healthy, violence-free lives Last year, our shelter provided 40,813 nights of service to 309 women and 436 children The room utilization rate was 92%, 86% of women increased their safety by completing a safety plan, 38% were employed at exit and 50% found affordable housing Additionally, our crisis line provided information and resource referrals to 2,574 people
