Salt Lake CAP Head Start and Early Head Start are Early Childhood preschool programs that provide education services for children living in poverty The program further facilitates the educational process by assuring that children are ready to learn by supporting medical, dental, disability and mental health services to facilitate the learning process One major goal is kindergarten readiness In addition, case management services and classes are offered for parents Salt Lake CAP Head start and Early Head Start serve over 2,300 children and their families each year at 70 locations in Salt Lake and Tooele counties Another primary focus of the program is child nutrition services

Weatherization In 1976, in response to the national energy crisis, the U S Department of Energy initiated the Weatherization Assistance Program The program helps low-income households, particularly those with elderly and disabled residents, reduce energy consumption This lessens the impact of utility costs on limited household budgets and helps stimulate self-sufficiency SLCAP through the Utah Division of Housing and Community Development provides the Weatherization Assistance Program for Salt Lake and Tooele Counties Benefits are provided in the form of non-cash repairs and upgrades to eligible households to make energy-efficiency improvements to those homes Participating households average nearly 33 percent in savings, or approximately \$285 per year, after the completion of weatherization improvements
