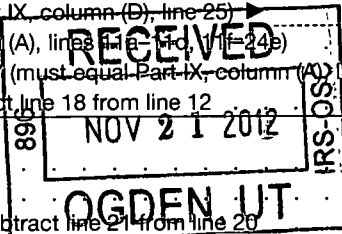

Additionally, this amount was significantly leveraged to serve as many children as possible through the donation to these therapists of services at 50% of the normal fee for these services
