Community Action Food Bank alleviates hunger by providing food/basic
needs packages, counseling, budgeting and referrals to other community
services. The program provided 22,880 food and basic needs packages to
6,054 unduplicated households (16,000+ people). The food bank also provided
food to 26+ community partner organizations for distributions to their
low-income clients. The total pounds of food distributed was 4.8 million.
Community Action Food Bank operates several of its own food pantries
located in Provo, Kamas, Coalville, and Heber City as wells as two community
gardens. The expenses include the value of the donated food from community
food drives and from grocers, food industry, the county jail and others,

The Family Development and Support Services Program provided a variety
of direct services to help eligible households stabilize and work
toward self-reliance. These services include: eviction prevention,
emergency shelter, case management, life skill training, goals setting,
help to move into new housing, and more. In FY 2012, 542 households were
assisted in this program.

The Home Buyer and Mortgage Counseling Program educates moderate and
low-income families on how to purchase a home and helps to resolve mortgage
problems. In FY 2012 the program helped 181 homes to be saved from
foreclosure, 156 seniors receive reverse mortgage counseling, 169 families bought their first home
or will be mortgage ready within 180 days.
