Columbia Industries provides pre-vocational training to 48 individuals with significant disabilities to help them achieve their highest level of employability. This is accomplished by providing services that are tailored to each individual's needs and abilities. Services provided include but may not be limited to: Intakes, assessments, Employment Plan development, discovery, skill development through work activities, and habilitation activities. These services are provided at our 14,400 sq. ft. retail thrift store (which also employs approximately 15 FTE support personnel) and our 6,500 sq. ft. assembly/business center employing approximately 4.5 FTE support personnel.

Columbia Industries provides vocational assessment, training and counseling, and work opportunities to over 26 individuals (clients) with moderate to severe developmental disabilities, promoting their self-sufficiency and independence in daily living using the resources of two janitorial departments. The primary responsibility of one of these departments is custodial and grounds keeping of a federal building of over 300,000 sq. ft. Primary responsibilities of the other janitorial department include custodial services of properties of a regional transportation system, and several other small businesses and organizations. Individuals in this program work to ensure that methods and outcomes are consistent with industry best practices. Support staff collaborates with clients to develop employment plans, strong

CI Employment Services (CIES) provides assessments, job search and retention services to individuals wanting to work in the community. This program goes through an intensive certification process (CARF) every three years to ensure the integrity of the program and Columbia Industries as a provider of services to people with disabilities. CIES provided services to over 90 individuals this last program year. The following is a list of the services and a short description of each service:

1. Community Based Assessment (CBA): This is an employability assessment done in a business within the community. A CBA lasts 2-3 weeks with the employer and the CIES Employment Specialist working
